



## On matters Public Finance and the Debt Ceiling

- The National Assembly raised debt ceiling from Ksh 6 trillion to Ksh 9 trillion in **October 2019 by approving Public Finance Management (National Government)(Amendment) Regulations, 2019.**
- The further raised the debt ceiling from Ksh 9 trillion to Ksh 10 trillion by amending section 50 (2) of the Public Finance Management Regulations 2015 – **7th June 2022**
- **Introduction of minimum tax** at the rate of 1% of the gross turnover – **Finance Act, 2020**
- **Introduction of Digital Service Tax** at the rate of 1.5% of the gross transaction value payable on income derived or accrued in Kenya from services offered through a digital marketplace – through the **Finance Act, 2020**
- **Increase of VAT** from 14% to 16%
- Budget days



## Parliamentary Committees: Missed Opportunities?

- The Sugar saga Committee Report conducted by the joint Departmental Committees on Agriculture, Livestock and Trade, Industry and Cooperatives which was premised on allegations of illegal sugar importation was dismissed by the House and was marred with allegations of bribery and outside influence.
- The Covid funds probe conducted by both the Senate Health Committee, the Departmental Committee on Health in the National Assembly and the National Assembly's Public Accounts Committee (PAC) who ordered forensic audits into the misuse of funds yielded no concrete proposals on holding those responsible for the funds accountable.



## 2/3 Gender Rule

- 2/3 gender rule was not achieved.
- **The Constitution of Kenya (Amendment) (No.6) Bill, 2018** was introduced in the House by Hon. Aden Duale. The Bill sought to increase the number of special seats necessary to ensure that no more than two-thirds of the members of the two Houses were of the same gender. However, the vote was deferred as there was lack of quorum in the House. - **28th November 2018**
- Hon. Gladys Boss Shollei introduced **Constitution of Kenya (Amendment) Bill, 2019 (No. 53 of 2019)** that sought to increase the number of women in Parliament through election and not by party nomination.
- Report of the Journey to Gender Parity in Political Representation for the period 2012-2018 from the National Gender and Equality Commission was tabled in the House for noting and dissemination – **25th July 2019**
- Chief Justice's advisory to the President on dissolution of Parliament for failure to enact the gender rule – 21st September 2020
- Discussion of the dissolution of Parliament Advisory due to the non-fulfilment of the 2/3 gender rule – 21st September 2020 (NATIONAL ASSEMBLY PROCEEDINGS 22nd Sept 2020)

## National Assembly and the Judiciary

1. Constitutional Petition No. 284 of 2019 (as consolidated with Constitutional Petition No. 353 of 2019)– 24 Acts were declared unconstitutional. The Senate had been aggrieved by the National Assembly’s action to legislate various Acts of Parliament without reference to the Senate and disregarding the provisions of Article 110(3) of the Constitution of Kenya 2010. This led to the Senate filing a Constitutional petition that culminated in the judgment given in Senate of the Republic of Kenya & 4 others v Speaker of the National Assembly & another; Attorney General & 7 others (Interested Parties) [2020] eKLR.

In its holding, the Court held that:

A Speaker of a House of Parliament must first seek the concurrence of the Speaker of the other House of Parliament, as to whether a Bill is one that concerns counties, and if it is, whether it is a special or an ordinary Bill, before the Bill can be introduced for consideration in the originating House;

- a) It is mandatory and a condition precedent for any Bill that is published by either House to be subjected to a concurrence process to determine in terms of Article 110 (3) of the Constitution whether the Bill is special or an ordinary Bill and that such determination is not dependent on “a question arising” as to whether the Bill is one that concerns Counties;
- b) The provisions of Article 110 (3) of the Constitution are couched in mandatory terms and is a condition precedent before any House of Parliament can consider a Bill;
- c) One Speaker cannot unilaterally make a decision as to whether the Bill does or does not concern counties or whether a question as to whether the Bill is one that concerns counties does or does not arise; and
- d) Any Bill or delegated legislation that provides for, or touches on, mandate or powers of Parliamentary Service Commission must be considered by the Senate as it directly affects the Senate’s ability to undertake its constitutional mandate including its ability to consider Bills that affect counties.

The import of this judgment was that the 24 Bills were taken back to the National Assembly for concurrence with the Senate.
