







Impeachment Motions



1. Motion for the removal from office, by impeachment, of the Governor of Taita Taveta County, **Hon. Granton Samboja** - October 2019

- Senate received resolution of County Assembly of Taita Taveta on 11th October 2019

- 11 Member Select Committee was established to investigate the proposed removal from office of Hon. Samboja on 15th October 2019

- Committee found that the grounds brought against the Governor were not substantiated.



2. Motion for the removal from office, by impeachment, of the Governor of Kiambu County, **Hon. Ferdinand Ndung'u Waititu Babayao** - January 2020

- Special Sittings on 21st, 28th and 29th of January 2020

- The Senate in plenary, found the three charges brought against the Governor to have been substantiated and resolved to remove from office by impeachment.



3. Motion for the removal from office, by impeachment, of the Governor of Kirinyaga County, **Hon. Anne Mumbi Waiguru** - 26th June 2020

- The Special Committee of the Senate considered the motion and found the charges brought against the Governor to have been unsubstantiated.

- Voted in plenary to dismiss the impeachment charges against the Governor.



4. Motion for the removal from office, by impeachment, of the Governor of Nairobi County, **Hon. Mike Mbuvi Sonko** - December 2020

- The Senate plenary considered the motion and found the four charges brought against the then Governor to have been substantiated.

- Senate resolved to remove him from office by impeachment.



5. Impeachment of **Hon. Mohamed Abdi Mohamud**, Governor of Wajir County

- Special Committee was formed on 6th May 2021 to investigate the proposed removal from office by impeachment of the Governor.

- The committee found that the allegations were proved and impeachment was therefore substantiated.
